One-off joining fee (NFRC Member) [Non-refundable, the fee includes validation of NFRC office audit and site audits by an NFRC CPS Inspector, to achieve Registered Contractor status and setup of temporary portal access.]	£295.00
Application inspection fee (per discipline) [Includes competent person assessment.]	£201.60
